A. SPECIAL EDUCATION TRANSPORTATION BID

The special education transportation bids were opened at 2 pm on July 20, 2007. Results were:

Safeway Training & Transportation Services, Inc.	\$80,820: \$449/day
The Provider Enterprises, Inc.	\$97,200: \$540/day

The bid is based on joint ridership only:
Fiscal implications: budget of \$185,000; low bid of \$80,820.

Christine Kenneway made a motion to award the Special Education Transportation Bid to Safeway Training & Transportation Services, Inc. Deborah Genthner seconded the motion. Motion passed unanimously; 5-0.
